After the 3 days has passed, and if the Buyer still has not fulfilled their contractual obligations, the Seller may elect to cancel the contract.

(lines 272-275 of the purchase contract) What this means to you as a Buyer or Seller is there is no â lautomatica at breach of contract. Depends on which side of the breach you all re on, I guess. Here a sampling of reasons that a CURE Notice might be issued: Soâ how does this play out? (Editors Note: If you want to talk to Shar more she loves to connect on FacebookEnter, THE CURE NOTICE, incorporated into the purchase contract in 2005:CURE Period: A party shall have an opportunity to cure a potential breach of this Contract.. The non-breaching party must issue a CURE PERIOD NOTICE to the breaching party detailing the non-compliance and giving

them 3 full calendar days AFTER delivery of said notice to cure the breach.. Are you counting days with me here? Thatâ? seffectively 5 days after the initial breach before the Seller can cancel.. If the non-compliance is not cured within three (3) days after the delivery of such notice (â? Cure Periodâ?), the failure to comply shall become a breach of Contract..
